Shop window displays.

- 1- The rule: the display of goods in a shop window is invitation to treat. What is the reason?
- 2- /A/ Retailers, who have limited stocks of the goods, make offer (while stocks last).

/B/ Innkeepers make offer (subject to availability of accommodation).

- 1- The rule: the display of goods on the shelves of a self-service shop is invitation to treat. What is the reason?
- 2- How can retailer retain a measure of control over the persons to whom he will supply goods?
 - Vending machines.
