## An Agreement Between: Damascus University, Syrian Arab Republic

## And The University Of Szeged ,Hungary (Szegedi Tudomanyegyetem)

- A. The president of Damascus University, Prof. Dr. Wael Mualla and the president of the University of Szeged, Prof. Dr. Szabo hereby affirm their intent to promote such exchanges as will be of mutual benefit for their respective institutions. Educational and academic exchanges are considered here to include but not be limited to:
  - 1. Development of mutually beneficial academic programmes and courses.
  - 2. Exchange of academic staff purpose of teaching and research.
  - 3. Reciprocal assistance for visiting academic staff and student.
  - 4. Coordination of such activities as joint research, lecturers and training.
  - 5. Exchange of documentation and research material in fields of mutual interest provided that, to the best knowledge of the respective institutions, there is no prohibition at law or otherwise against the exchange
  - 6. Exchange of student for study and research.
  - 7. Exchange and training of administrative staff.
- B. Details of the implementation of any particular student exchange or faculty-related activity resulting from the Memorandum of Understanding shall be negotiated between the two institutions as such specific case may arise and will be outlined in a Supplementary Student Exchange Agreement or faculty Exchange Agreement between the institutions. Supplementary Agreements are subject always to availability of sufficient funds to the respective institutions.

This Memorandum of Understanding may be amended or terminated at any time by either party provided that notice of termination or amendment is provided by the notifying party to the other party within thirty (30) days of the date on which the termination or the amendment is intended to become effective any amendment or termination shall not have effect on any arrangement in plat is at the time that the notice is provided, where the arrangement arises from any Supplementary Agreements resulting from this Memorandum of Understanding.

The parties herein will appoint a coordination committee composed of one representative per institution: the representative will be in charge of planning, executing, and supervising any all activities performed as well as of the elaboration of an annual report concerning the objectives and goals accomplished throughout such time.
