B1- the student make a research after passing in all courses in a theme approves the university council depending on the specialized section council suggestion and an accepted for the University council at least. Of time

of making the research one year from the accepting date from the University council and write the research theme and must not to be longer than the period of time that the student decided to present it the master letter for 3 years otherwise will cancel the student research

2-The student will give in 6 months from the exam result date maximum to complete his research theme

3-The student has to make a scenario for his research every 4 months in front of a quarter from the specialized section and if the students get a greater fiction result in the end of the last 4 months the students will be canceled from the master

c-The student gives results his research a letter that the court accepting it after a public decision

Clause 6-The same section in all courses from previous courses in clause A5 in a decision from the University council depending on the specialized section decision

Clause 7- 1. The final exam Mark consists of two parts one of it for all works during the year and specialized 40% from the marks and the other parts specialized 60% from the marks

2. The student is considered successful in the courses if he got a mark 60% from the final work and he is not considered successful in the exams courses unless if he got minimum 40% from each of two parts.

clause 8- It is required for student exam entry courses to has minimum of 90% of attendance from the total specialized hours from the course otherwise student is proscriptive for the exams and it is acceptable for the

section console in unnecessary situation to accept for the student to do exam if he got minimum 75% from attending with all rules and University council puts

Clause 9:

1.The student period select for masters degree in the courses parts in one year and it is right for a failed students in the first year to restudy the courses that he failed it just in one year and if he failed again in just one course he is dismissed from the master's degree except the Islamic economic master and it it's study. Will be maximum in the first year in 2 years and in the first and second years in 3 years and if student failed during it in all courses he will dismiss in master's degree

2. The student will move to the second year in the Islamic economy Master if he passes in all courses of the first year depending on the studying the plan or if he failed maximum into courses in the first year courses.

3. The student who has two courses maximum and the end of the courses has the right to enter the completed exam that it's date will determine by the university council and the studying started is determined depending on the dependent universities calendar.

Clause 10: It is allow teaching one or two English courses and determined from the University council decision according to the specialized section console suggestion at the beginning of each year.

SECOND TERM

The PhD's degree

Clause 11: Required for the student in PhD's degree the following:

1. To have the Master's degree minimum in rate good from one of University of the Syrian Arab Republic or from a college or high center that they are recognized from the University council as following
