القانون الدولي الخاص: It is the branch of law that seeks to resolve the status and legal relationships that contain a foreign element.

أو

The branch of law which determines the nationals of the state, the treatment of aliens, and also decides the proper solutions that should be followed in cases of conflict of laws and conflict of jurisdiction of court.

المواطن:

To be a national means that an individual is a citizen under the terms outlined in the State's legal instruments or that the individual has been granted nationality through a decision made by the relevant authorities.

Those instruments can be a Constitution, a Presidential decree, or a citizenship act
